Tech Prep Indicators of Performance Definitions (Numerators and Denominators)**

**Secondary Tech Prep Student**-Definition in Perkins IV: A secondary education student who has enrolled in 2 courses in the secondary education component of a tech prep program.

**Postsecondary Tech Prep Student**- Definition in Perkins IV: A student who (A) has completed the secondary education component of a tech prep program; and (B) has enrolled in the postsecondary education component of a tech prep program at an institution of higher education described in clause (i) or (ii) of section 203 (a)(1)(B).
